The undersigned consents to the filing of a UCC financing statement in the appropriate place and grants PRODUCTION AUTOMATION a security interest in all goods, equipment, inventory and all proceeds and products thereof together with accessions and accessories thereto (collectively referred to as "Collateral"). Attachment occurs at delivery to Applicant or to a third party at Applicant's direction. Applicant grants to PRODUCTION AUTOMATION a limited power of attorney to execute (if signature is required; or simply file if a signature is not required) and file a financing statement in favor of PRODUCTION AUTOMATION covering the Collateral.
