Warranty replacements will take approximately two weeks. EasyBraid will quote repair charges necessary to bring your unit/product up to factory standards.

**Desoldering Braid:** EasyBraid expressly warrants that for a period of two (2) years from the date of manufacture, Desoldering Braid will be free of defects in material (parts) and workmanship (labor) when stored appropriately and contained within its original container. Each bobbin is individually stamped with a lot code. A certificate of compliance is available.

The RMA number must appear on the outside of returned cartons, and EasyBraid has the right to refuse all return shipments which do not bear the RMA number or which are shipped freight collect.
